I was continually at the front with my organization with the exception of a couple weeks after the 2nd Battle of the Marne during the month of August 1918, when we had a rest at Bissey la Cote, Cote d'Or in the Chatillon's area. From the time of the signing of the armistice, when we were at the Verdun front, till our departure for America, we were stationed two months at Mandres, Aisne, and two months in the Le Mans embarkation area at St. Biz en Belin, Sarthe. Was held about three days at Brest before embarking for U.S.A.
